Fabulous Fun and Fashion at the 39th Annual Scholarship Luncheon and Fashion Show

Also featured is Ryan Roberts, a Canadian designer transplanted to Los Angeles, who has an understated and sophisticated collection. These fashions will be joined by timeless clothing from local kama'aina retailer, Tapestries by Hauoli (located in Ala Moana Center and Pearlridge).

Keeping with the fashion theme, there will be numerous boutiques selling clothes, accessories, foods and crafts beginning at 9 am. Doors to the ballroom will open at 11:30 with lunch at noon. During lunch entertainment will be provided by the Ryukyukoku Matsui Daiko Hawaii, the Paranku Club of Hawaii, and Jordan Segundo, Hawaii's Idol, who will also be emceeding the event. After lunch, the fashion show begins, narrated by Kelsey Farris, celebrity stylist and designer representative from Los Angeles.

Combined with a silent auction, doorprizes, and raffle, a wonderful afternoon is planned by the Fashion Show Committee and Co-Chairs Val Kato and Jennifer Waihee. As oft repeated to customers throughout the day by our order takers, it is as follows. An okidog is born when a flour tortilla, steamed to perfection, is placed on the assembly line. Next, a hotdog smothered in chili is carefully placed on the tortilla. The tortilla is rolled over one time and shoyu pork and shredded lettuce are strategically
